	 \$100 if complete application is received 30+days prior to event \$150 if complete application is received 15-29 days prior to event \$200 if complete application is received 8-15 days prior to event \$300 if complete application is received less than 7 days prior to event 		
3.	Set-up of the tent/s, including tables, chairs, etc., will need to be COMPLETE before a fire marshal inspection can take		
	place, and a representative of the applicant needs to be present for the inspection.
