

5 Year Employment Trends: Albemarle Has Experienced Steady, Healthy Job Growth, with the Private Sector Generating the Overwhelming Majority of New Jobs.

Between 2002 and 2007, the overall number of jobs increased every year, with the total number rising from 39,478 to 50,405 or by about 28%. In 2007, the private sector accounted for 70% of the County's employment base, and generated 71% of the new jobs during the five year period. Employment in the private and public sectors grew by roughly the same five-year average annual rate, 5.18% and 4.64% respectively. Note that, during this time frame, in contrast to earlier five year blocks, employment in the manufacturing sector actually grew slightly. Employment in the agricultural sector essentially held steady. Educational Services (in the State Government category), Retail Trade, Private Sector Professional/Technical Services, Private Sector Health Care, and Private Sector Accommodation/Food Services experienced the largest growth in terms of the number of new jobs.

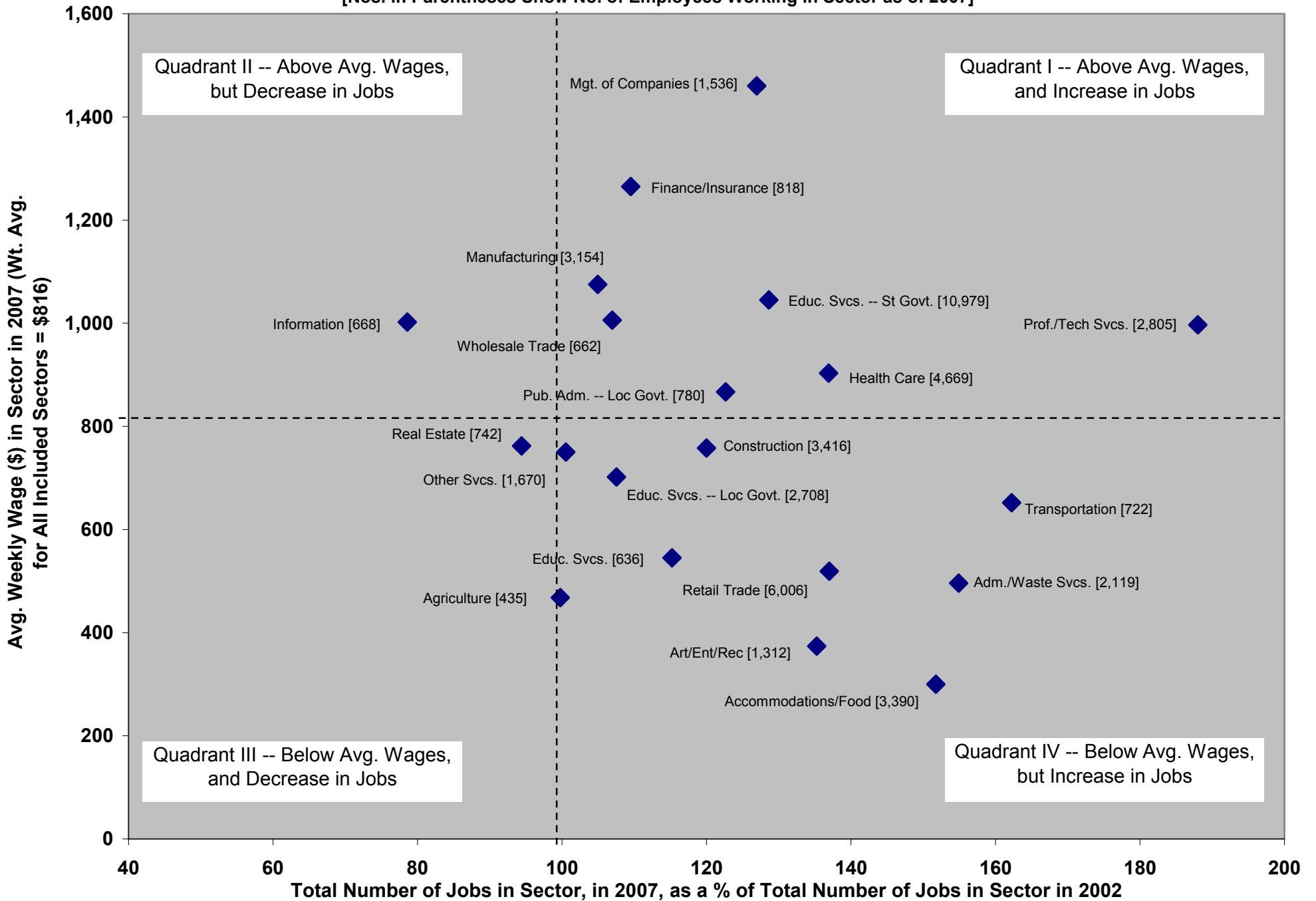
